It is agreed that enrollment, as specified within this registration agreement, may be cancelled only by written notice directed to the Head of School or another administrator and delivered to the school office on or before May 16, 2008. The deposit remains non-refundable. I/We understand that no portion of the tuition for the summer program will be refunded if the student is absent, suspended, withdrawn, dismissed or otherwise should fail to complete the summer program. Should collection or legal action be instituted on this contract, I/we agree to pay all costs and disbursements including all attorney fees incurred to collect and enforce this indebtedness.

The Dorris-Eaton School shall have the right to dismiss any student for unsatisfactory achievement or conduct. The School's rules of conduct apply both on and off campus. I/we understand that The School retains the right to terminate enrollment in the event of non-compliance with school policies, rules or regulations. I/we understand that infraction of school policies and rules will result in my/our child being terminated from the program and that no tuition will be refunded. A student may also be dismissed if the parents/guardians have not cooperated with The School regarding the child's discipline needs or are not following school rules. I/we understand that my/our child must be able to participate as a member of a class, handle group dynamics and be able to participate in routine school activities. I/we understand that my/our child may be dismissed if said child is unable to adjust to Dorris-Eaton and that no refunds will be made. Non-payment of fees and charges herein provided for shall also be grounds for dismissal.
